### Installation

## The following preparation steps need to be made to the existing scaffold prior to use of the OneUp™ Safety Platform:

1) Check all components carefully for damage and correct operation of the sprung retaining hooks and adjustable footplate.

- 2) Fully board and install guardrails to the working level.
- 3) Install ledgers to the level above the working lift.

#### The following steps need to be taken to install the OneUp™ Safety Platform:



1) Open the product by disengaging the Velcro strap (3) from the ladder rung, taking care not to trap your fingers in the hinges.

- 2) Orientate the platform side bars into position.
- 3) Offer the OneUp™ Safety Platform to the top guardrail.

4) Connect the platform to the top guardrail of the working lift. Ensure that the retaining hooks fully lock around the guardrail.



5) Inspect the position of the ladder feet. If these are not sitting on a flat surface, adjustments need to be made to either the footplate position or guardrail height. Both the platform and the footplate should be horizontal.

6) Connect personal fall protection equipment and ascend the ladder by using the platform side bars. The subsequent lift ledger will form a temporary guardrail.



7) Install guardrails to the level above the working lift. These can be handballed to the user, or placed in the gap between the OneUp™ Safety Platform and the working lift guardrail, prior to user ascension.

8) To move / uninstall the OneUp<sup>™</sup> Safety Platform, manually retract the retaining hooks simultaneously and disengage from the guardrail. Fold up the platform using the side bars and secure using the Velcro strap.
